





Fig. 2: Documents of Work Programme


Fig. 8: World Heritage


Fig. 12: Activity of CIVVIH



# Fig. 1: Short Summary


CIVVIH works for the protection and management of historic towns and against the menaces threatening urban identity and heritage.



# Fig. 3: By-Laws and Règlement du CIVVIH

The revised By-Laws have been sent on 30 May 2020 to the ICOMOS Secretariat and to the President of the ICOMOS Scientific Council.

The Scientific Council Officers have been reviewing all those that have been received. **The By-Laws sent by CIVVIH are OK**, and have been submitted to the Board with a positive advise for approval. The Board has approved our revised By-Laws in March 2021. Gaia Jungeblodt, ICOMOS Director, will send shortly this decision.

Only 16 ISCs from 29 have sent their revised By-Laws. CIVVIH and 7 other ISCs will get approved regulations.





Fig. 4: Membership









Fig. 7: Partnerships and Collaborations


Each year CIVVIH's experts participate in the evaluation of World Heritage nominations giving the high professional opinions for WH.



# Fig. 9: Scientific Work Program


The main topic of the Committee is represented by historic cities as a model for sustainability and cultural heritage as the fourth pillar of sustainable development.

The two chairs Sofia Avgerinou-Kolonias and Alvaro Gómez-Ferrer Bayo of a Working Group have sent the draft document: The Valetta Principles for the Safeguarding ans Management of Histroric Cities, Towns and Urban Areas - Update March 31th 2021.




# Fig. 10: Meetings
