#### Thematic presentations coordinated by Samir Abdulac

The Statutory Meeting was suspended to allow for two pre-arranged presentations to be made to the CIVVIH members on behalf of ICOMOS France. These aim essentially at presenting the original initiatives concerning the World Heritage cities in France, as well as abroad.

Samir Abdulac introduced Minja Yang, founding member of the 'Association of French World Heritage Sites'. She gave a presentation about the work of the Association which was formed in 2007 to create a platform for exchange of information, advice and thoughts and to promote cooperation between the World Heritage sites in France. The Association works on 3 axes:

Management plans,
Communication, culture, mediation,
International relations.

It particularly assists in the elaboration of declarations of OUV and the preparation of Management Plans founded in OUV. Today, France numbers 37 WH sites and a convention signed in 2011 defines the rules of cooperation between the State and the association.

Samir Abdulac also introduced the second presentation by Bruno Delas, Director of Studies in the University of Lyon about the ongoing project being undertaken by the Organisation of World Heritage Cities (OWHC/OVPM) in conjunction with ICOMOS, UNESCO, the European Union, the Getty Conservation Institute, the World Heritage Centre, and the City of Lyon.

The project has so far produced 45 case studies showcasing a wide range of projects that have been undertaken in World Heritage cities. ICOMOS' contribution to the project has been delegated to CIVVIH and is being coordinated by Samir Abdulac who is also participating to the works of the piloting committee for the project. The PowerPoint presentation was also presented during the previous week at Sintra, Portugal during the Congress of Mayors of the World Heritage Cities. A selection of this information is planned to be diffused in 2012.

#### i) Adoption of the Valletta Principles

#### ii) Congratulations to Alvaro Gomez-Ferrer Bayo

The Acting President reminded that CIVVIH member, Alvaro Gomez-Ferrer Bayo, had been recognised as an Honorary Member of ICOMOS, for his distinguished service to ICOMOS. Alvaro was warmly congratulated by the meeting.



During the CIVVIH annual meeting Angela Rojas, the elected president of the Ibero-American Subcommittee gave a verbal report to the meeting on recent activities of CIHIB.



#### **Membership Database**

David Logan had agreed to assist with the coordination of the database. The proposal was strongly supported by the members.

#### **Honorary Memberships**

It was decided unanimously that Ray Bondin be made an Honorary Member immediately. Other nominations be postponed pending the preparation of selection criteria.

#### **Discussions on 'Integrity'**

Giora Solar reported that, on behalf of CIVVIH, he had attended during the General Assembly a discussion at ICOMOS' World Heritage Unit about the definition, application and meaning of the term 'Integrity'. He advised that a paper is being written on this subject by the ICOMOS World Heritage Unit for distribution to the officers of ISCs.

CIVVIH' participation in the "Youth and Universities" Forum at the UNESCO Headquarters

On Wednesday, November 30, took place the "Youth and Universities" Forum in Hall Ségur at the UNESCO Headquarters.

About 10 French and international schools and universities in the fields of heritage and architecture presented their activities and projects. This was an excellent opportunity for participants of the Assembly to establish contact with younger individual interested in the same topics. The establishments and programmes were the Ecole de Chaillot (Paris, France), the National Landscape school of Versailles (France), the Institut de recherche et d'études supérieures du tourisme (IREST, Paris, France), the Institute for Planning, Tourism and Urban Planning from the Michel de Montaigne University and of the School of Architecture of Bordeaux (France), the Ecole d'Avignon (France), the Raymond Lemaire International Centre for Conservation (RLICC, Leuven, Belgium), the Centre de perfectionnement aux métiers du Patrimoine de la Paix-Dieu (Namur, Belgium), the University of Laval (Québec, Canada), and the Master of Arts in World Heritage Studies from the Brandenburg Technical University of Cottbus (Germany).

#### **Triennial Work Plan**

The Acting President presented the proposed triennial research topics of the Scientific Council and invited a discussion on what should be included in the CIVVIH's forward Work Plan for the next triennium 2011-14. Alvaro Gomez-Ferrer Bayo recommended that CIVVIH should spend some time considering what 'Integrity' means within the framework of CIVVIH activities, as well as the implications of the HUL Recommendation.

David Logan advised the meeting of his recent involvement in facilitating the Mayors' Workshop at the OWHC/OVPM Congress in Sintra and the various heritage management issues that had been raised by the mayors and advisors. These included a range of impacts associated with tourism, loss of inhabitants from historic centres and impacts associated with climate change.

A number of members expressed a view that CIVVIH's Work Plan should be focussed on practical, rather than theoretical, issues. It was agreed that further consideration of the Work Plan would occur before May when it would be finalised.

### a. CIVVIH's 2012 Annual Meeting

Teresa Colletta announced that the Italian ICOMOS had agreed to host the next CIVVIH meeting in Naples to coincide with the World Urban Forum of 2012. It was agreed that the CIVVIH Annual Meeting will take place in Naples, Italy the first week of September 2012.





## b. Joint meeting with THEOPHILOS ISC in Bacu, April 2012.

THEOPHILOS would like to hold joint discussions with CIVVIH on the HUL Recommendation, recently adopted by UNESCO. They are seeking involvement of at least 8 CIVVIH members. The meeting will occur as part of THEOPHILOS' annual meeting.

## c. Subcommittee for the Mediterranean region

After proposal of Nur Akin, the subcommittee will hold its next meeting in Izmir at the end of May 2012.

#### **Election of CIVVIH President**

It was unanimously decided that Sofia Avgerinou-Kolonias be appointed President for the next 12 months pending the elections due to be held at the next CIVVIH Annual Meeting in 2012.
